## Planning Board Meeting Minutes of December 11, 2023

Meeting was called to order at 7:16 pm.

**Request to withdraw** without prejudice Special Permit # 312 and Site Plan 70 for Architectural Insights.

The Planning Board was ok with withdrawing the Special Permit and Site Plan applications. Motion to approve by Mr. Eichacker, second by Mr. Dufresne – 5 yes vote.

A site visit has been scheduled for **December 22, 2023, at 10:00 am** at the Agilitas Solar Site - Cutler Road Extension.

ANR review Carol Sausville - 87 Pleasant Street – Map 15 Lot 22.1 - To illustrate a single building lot, Lot A from the existing lot (0.246 acres), remaining land has 0.346 acres and sufficient frontage.

Motion to approve the ANR for Sausville on Pleasant Street made by: Mr. Londergan, second by Mr. Eichacker - 5 yes votes.

ANR review 51 & 57 Dean Street – Map 14 Lot 32.2 & Map 15 Lot 3 – Proposed Lot 3.1 is considered to be a building lot. Proposed Lot 3.2 is considered to be a building lot. Proposed Lot 3.3 is to be considered a building lot. All proposed lots have enough acres and sufficient frontage.

Motion to approve the ANR for Burke on Dean Street made by: Mr. Londergan, second by Mr. Dufresne - 5 yes votes.

ANR review Starsiak -380 Brimfield Road – Map 9 Lot 71 – Increase the area of 380 Brimfield Road to 1.21 acres. Remaining land has sufficient acreage and frontage.

Motion to approve the ANR for Starsiak on Brimfield Road made by: Mr. Londergan, second by Mr. Dufresne - 5 yes votes.
