

**RESULTS OF
SPECIAL TOWN MEETING
JUNE 8, 2010**

58 VOTERS ATTENDED

Moderator, Kathleen Crevier, called the meeting to order at 6:30 P.M. More than a quorum of 25 were present.

ARTICLE 1: VOTED UNANIMOUSLY that the Town *transfer* \$4,000.00 from Free Cash to the Veterans Services Account.

ARTICLE 2: MOTION MADE AND SECONDED: I move that the Town *transfer* \$3,140.56 from Free Cash to offset the deficit in the Snow and Ice Account.

AMENDMENT - MOTION MADE AND SECONDED: Town Accountant, Madeline Witaszek explained that the amount needed to be changed to \$3,552.50; stated that the invoice came in after the Warrant was posted. I, Susan Como, Finance Committee Chairperson, make a motion to change the amount to \$3,552.50.

AMENDED MOTION – VOTED UNANIMOUSLY

ARTICLE 2: ORIGINAL MOTION AS AMENDED – VOTED UNANIMOUSLY

ARTICLE 3: VOTED UNANIMOUSLY that the Town *transfer* \$4,898.08 from Free Cash to the Highway Department Salary Account.

ARTICLE 4: VOTED UNANIMOUSLY that the Town *transfer* \$8,090.00 from Free Cash to the Property and Liability Insurance Account

ARTICLE 5: VOTED UNANIMOUSLY that the Town to *transfer* \$3,000.00 from Free Cash to the Ambulance Payroll Account.

ARTICLE 6: VOTED UNANIMOUSLY that the Town *transfer* \$1,000.00 from Free Cash to the Advanced Life Support Account.

ARTICLE 7: VOTED UNANIMOUSLY that the Town to *transfer* \$1,980.00 from Free Cash for the Town's share of a matching grant to the Warren Fire Department by the Massachusetts Department of Conservation and Recreation.

ARTICLE 8: VOTED UNANIMOUSLY that the Town *transfer* \$7,000.00 from Free Cash to the Treasurer Tax Title Expense Account.

ARTICLE 9: VOTED UNANIMOUSLY that the Town *transfer* \$95.62 from the Animal Control Expense Account to pay a previous year bill to the Wickaboag Veterinary Clinic. (9/10'S Vote Required)

ARTICLE 10: VOTED UNANIMOUSLY that the Town *amend* Article 7 of the 2009 Annual Town Meeting, which appropriated funds for the replacement of a boiler at Fire Station B, to allow for remaining funds in said article to be spent for the replacement of two oil tanks at Fire Station B.

Business of the meeting being completed, a motion was made and seconded to adjourn the meeting at 6:43 P.M.
