GREETING: In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the Town of Warren qualified to vote in elections and in Town affairs to meet at the Quaboag Regional Middle High School, 284 Old West Brookfield Road, Warren at 6:30 PM on Tuesday, May 10, 2016 then and there to act on the following articles:

ARTICLE 1: To see if the Town will vote to raise and appropriate, transfer from available funds or borrow \$ 244.84 to further fund the Insurance Liability Line Item as approved pursuant to Article 4 of the May 12, 2015 Annual Town Meeting to cover shortfall through June 30, 2016, or take any action relative thereto.

(Board of Selectmen)

ARTICLE 2: To see if the Town will vote to raise and appropriate, transfer from available funds or borrow \$15,000.00 for procurement of Information Technology hardware, software and services for improvements to information technology within Town departments and to authorize the Board of Selectmen to enter into all contracts and agreements upon such terms and conditions as the Board of Selectmen may determine to be in the best interests of the Town regarding such improvements, or take any action relative thereto.

ARTICLE 3: To see if the Town will vote to raise and appropriate, transfer from available funds or borrow \$7,000.00 to further fund the Veteran's Services Line Item as approved pursuant to Article 4 of the May 12, 2015 Annual Town Meeting to cover a shortfall through June 30, 2016, or take any action relative thereto.

ARTICLE 4: To see if the Town will vote to raise and appropriate, transfer from available funds or borrow \$350.00 to pay a previous year's invoice (FY 15) to Charles River Medical Group, or take any action relative thereto.

(Board of Health)

ARTICLE 5: To see if the Town will vote to transfer \$1,000.00 from the Landfill Supplies Account to the Monitor Wells Account pursuant to Article 6 of the May 12, 2015 Annual Town Meeting to cover expenses, or take any action relative thereto.

(Board of Health)

ARTICLE 6: To see if the Town will vote to transfer \$3,865.74 from the Health Insurance Account to the Retiree Medical Insurance Account pursuant to Article 4 of the May 12, 2015 Annual Town Meeting, or take any action relative thereto.

ARTICLE 7: To see if the Town will vote to transfer from available funds the sum of \$30,000.00 to the Maturing Debt and Interest Account to pay down principal on debt issued for Downtown Design Engineering pursuant to Article 19 of the May 29, 2013 Annual Town Meeting, or take any action relative thereto.

(Treasurer)

ARTICLE 8: To see if the Town will vote to raise and appropriate, transfer from available funds or borrow \$11,000.00 to fund the cost of tree work at the Town Cemetery; Shepard Municipal Building Campus and the Sewer Department Campus, or take any action relative thereto.

(Tree Warden)
