### SEPTIC SYSTEMS

Septic Installers Permit	\$200.00
Perc test dates: Percs only done when ground is not frozen (March-December)	
Up to two perc holes with 4 deep holes	\$200.00
Additional holes	\$75.00 per hole
<b>Disposal Works Permit (Includes below fees. \$250.00 total, includes new installations and repairs.)</b>	
Plan Review	\$100.00
Installed System Inspection	\$50.00
Top Soil & Seeding Inspection	\$50.00
Re-Inspection (if needed)	\$50.00

In the event of a cancellation, applicant must notify the Board of Health a minimum of 24 hrs prior to the testing time. Weather conditions will be considered with last minute cancellations.

Food Establishment Permit & Milk Permit	\$110.00
Re-inspection at food establishment for violations	\$50.00
Temporary Food Pt (if not run by Serve Safe certified personnel)	\$50.00/booth per event
Temporary Food Pt (if run by Serve Safe certified personnel)	<b>FREE OF CHARGE</b>
Seasonal Food Pt (6 months or less)	\$50.00

### OTHER PERMITS

Permanent Rubbish Dumpster Permit (over 3 months)	\$10.00 per year
Mobile Home Park (must provide yearly rules and regulations)	\$200.00
Rental Inspection	\$75.00 per unit per inspection
Funeral Home Permit	\$50.00
Well permit for each well installed	\$75.00
Licensed Tanning Permit	\$50.00
Tobacco Resale Permit	\$50.00
Landfill/Transfer Station Permit (Valid: July 1 <sup>st</sup> thru June 30 <sup>th</sup> )	\$80.00
