Business:

- Mr. Atkins was in attendance to discuss the (6) reasons the South St. landfill closure application was deemed administratively deficient:
 - 1. A notice of Landfill Operation is to be filed with the Worcester Registry of Deeds and a copy will also be submitted to the Department of Environmental Protection
 - 2. An electronic copy of the application needs to be filed via online ePlace portal in accordance with MassDEP's electronic filing requirements
 - 3. Discrepancies on plans regarding scale, and pre/post construction contours of the land Mr. Atkins said that full sized plans are attached to revised Construction

Closeout Report, as-built plans were submitted and additionally a colorized plan was submitted for clarity.

- 4. MassDEP wanted more information on soil type and the materials brought into the facility for capping work. Mr. Atkins noted additional information used for the West Landform capping project have been directly added to the revised Construction Closeout Report.
- 5. MassDEP was looking for discussion of deviations in the application, specifically about approval of soil that did not meet #200 sieve specifications. Mr. Atkins has added discussion to the revised Construction Closeout Report. A couple sieve tests showed results of finer soils than original specifications which were added to other soil material and used in the flat top section because it was determined that the mixture with finer materials would be beneficial in terms of providing more erosion control, and low permeability.
- 6. MassDEP noted that several forms did not appear to correspond to contents of application. Mr. Atkins responded that approved documents were previously submitted in June 2014 with main landfill on eastern side was closed. Additionally, form BWP-SW-43 has been updated and copies are included with revied Construction closeout Report.
- Mr. Lacey discussed the potential possibility of donating \$250 to Lucy Stone Park to help support local volunteers including Tim O'Brian. Mr. Lacey says the board would need to ask for a budget modification and is unsure if it would be feasible because of current COVID-19 hardships. Mr. Czub comments the town of Warren should get results if the Lucy Stone Park request was ever to be granted.
- In response to Tom Syre's proposition regarding glass recyclables, the town already has a glass recycling program in place.
- Tamara Dufesne was in attendance to discuss the open position for Animal Inspector. The monthly stipend for this position is \$75 per month but pending budget approval for 2022 fiscal year may increase to \$100 per month. Mr. Makowski motions to appoint Mrs. Dufesne as the Animal Inspector for the Town of Warren, Mr. Czub seconds, AIF.
