7:42 pm: CF asks KL if he thinks the pep rally at school was a wise choice. He says they are under DESE guidelines

7:45 pm: KL gets ready to close meeting. Mike Baril says he had a request to be put on the agenda and asks why it was denied, there was a misunderstanding in what Mr. Baril wanted to present. Mr. Baril asked for 600 Old West Warren Rd. to be put on the agenda because he is concerned about contamination at the property. According to Mr. Baril, the copart manager doesn't have a hazardous waste permit, the facility doesn't have hazmat equipment and toxic chemicals have been leaking into the ground. Mr. Baril is most concerned with why the Planning Board has not reaching out to the Board of Health about possible contamination. Mr. Baril says 2 Mondays from now is the final hearing to vote on the permit for expansion. KL asks Mr. Baril to get the original complaint put into DEP. Mr. Baril asks for the Health Inspector to go to the site, KL says he is not sending our Health Inspector to the site she is not an industrial hygienist our last Health Inspector had those qualifications.
