BOARD OF SELECTMEN

MINUTES OF AUGUST 6, 2020

PRESENT: Mr. John A. Nason; Chairman, Mr. Marc Richard; Vice-Chairman and Mr. David Dufresne, Clerk (VIA ZOOM) ATTENDEES: Atty. Jeffrey Blake, Mr. Shawn Romanski, Mr. Chris Bone, Mr. Don Kurpaska, Mr. Matt Sokop, Atty. Heather Parent, Mr. Peter Krawczyk, Mr. Don Makowski, Ms. Carol Sausville and Mrs. Lisa Digris

Opened the Meeting at 1:00 PM

Mr. Nason opened the meeting and dispensed with the Pledge of Allegiance at this time. Today's meeting was called by MassDEP as an Enforcement Hearing and was to be a joint meeting with the Sewer Commissioners, however none of them were in attendance in person or viz Zoom.

After the introductions were made, Mr. Bone (Tighe & Bond) stated that about the staffing issue, the town has done everything that they can do at this point. The issue with attracting and retaining employees, especially a Grade 5 operator, is the pay scale. We are currently down one employee (Gr. 5). This was at issue at the last Enforcement Hearing.

Mr. Sokop from MassDEP stated that he identified the violations (attached) that need to be addressed. The EPA could step in and impose fines. His intent today is to move forward in a productive manner. Today's discussion revolves around staffing levels, equipment maintenance and the Chlorine Alarm System. Chief Operator, Shawn Romanski stated that he has ordered equipment and ran the lines necessary, as he is less than hopeful to get another operator in order to do testing in a safe manner. He would like to hire someone with experience, however as stated at the onset, our pay scale tends to restrict our hiring or retention is often the problem.

Atty. Blake stated that the hiring/staffing issue was a matter of economics and the Sewer Commission is working on amending the wage scale, however it is contingent upon town meeting approval.

Dan Kurpaska suggested that considering everything, he would highly recommend reducing the plant from a Grade 5 to a Grade 4 plant. This would require the Sewer Commission to submit an application to DEP to reduce the grade level and would also require a new O & M. This would allow use of a weekend operator appropriate to their grade level. No grade level is required for the collection system.

A closer look at the current rates is in order as well. While DEP understands that the town doesn't like to pass along added costs to the consumer, it is necessary from time to time in order to maintain the minimum standards. Residential properties currently are billed \$375.00/EDU. Commercial is billed \$5.14/1K gallons. Mr. Bone will look at surrounding towns for a comparison and will send to DEP and the Sewer Commission (S. Romanski). Again, Mr. Kurpaska recommended a formal request from the town to reduce to a Grade 4 plant, which will help the town immensely regarding compliance.

Mr. Romanski stated that he feels it is easier to raise rates, as the complexity of the position is too much for a Grade 3 operator. Atty. Parent (counsel for DEP) stated that they are just trying to find a solution to the staffing issue as we need to comply, plain and simple. A discussion on the matter will be on the Sewer Commissions agenda for August 26th and then they will report back to DEP. All agreed.

Also, Mr. Kurpaska questioned if the town had a MOU with CSX for repair. Mr. Romanski stated that we do not. Access to the pipe is vital and this should be done as soon as possible. Atty. Parent will send a draft to Atty. Blake to review the facts of the Enforcement Hearing.

NOTICE OF ENFORCEMENT CONFERENCE

THIS IS AN IMPORTANT NOTICE. FAILURE TO RESPOND TO THIS NOTICE COULD RESULT IN SERIOUS LEGAL CONSEQUENCES.

Dear Mr. Romanski:

MassDEP (MassDEP or the Department) personnel have observed that staffing levels, equipment maintenance and the Chlorine Alarm System at the Warren Wastewater Treatment Plan are not in compliance with one or more laws, regulations, orders, licenses, permits, guidelines, or approvals enforced by MassDEP. In addition, there is continuing noncompliance with the requirements of the Administrative Consent Order executed on January 26, 2018 (ACOP-WE-17-0000809). The noncompliance includes a failure to meet the minimum requirements of the WWTP according to regulations 314 CMR 12.00.

The Department intends to take enforcement actions in response to the noncompliance. Possible actions include issuance of an enforcement order, and/or a civil administrative penalty. Prior to proceeding with enforcement action, MassDEP requests that you attend a virtual enforcement conference on the following date and time:

The purpose of the enforcement conference is to provide you with the opportunity to discuss the alleged violations and reach a negotiated settlement with the Department in order to return to compliance.

At the enforcement conference, the Department may discuss assessment of a civil administrative penalty for the alleged violations. The Department considers several factors in determining whether to assess a penalty and the amount of a penalty for each violation. Some of the factors that MassDEP considers, and for which you may wish to provide information, include, but are not limited to, steps taken to prevent the violation or to promptly return to compliance after the violation, or to remedy and mitigate any harm caused by the violation; your financial condition; the public interest; and any other information that can be provided. Please note that if you intend to assert that you do not have the ability to pay some or all of a penalty, the Department will require that you provide documentation to support the assertion. The Department may have legal counsel present at this enforcement conference. You may also wish to have counsel present at this meeting.
