#### 10. Old Business:

a. Active Shooter committee: Mr. Dufresne stated that the Fire Chief and Police Chief are working getting everyone together. The Police are making a big effort to be present at the schools and having the children get to know them. At the choir concert they had more than the school expected, even though it was hot they keep the doors closed. It was good to see everyone trying to do their part.

b. Police move: It is amazing all the details that need to happen before they can continue. There is extra testing that needs to be done to the building and more

requirements that need to be meet than a normal building.

## 11. Town Administrator Report:

a. The auditor Jim Giusti met with the accountant today and had no findings. He was very pleased with everything. He will be coming in on June 23 to do a report to the Board. There will also be a single audit for the ARPA funds that will be about \$8,000.00 so we need to set aside that money out of ARPA.

b. Mrs. Dusty and I had a video call with a representative from Comcast, he stated that we have the lowest download speed that a business can have, and we would need to upgrade if we are going to a VOIP system and if we don't have great Wi-Fi, we will need to fix that. He will be coming in and doing a demonstration for you once we

have the prices for their system.

c. Mr. Ferrera and Mr. Dufresne had a meeting last Friday 6-3 with the Banking Commissioner due to Mr. Dufresne's efforts. They were surprised at the lack of communication from the bank to the town. They said that they were impressed at the number of residents that sent letters in, because of this they are taking this closure very seriously. They did notice that the Bank has lost lots of clients now. Mr. Ferrera said, "What did the Bank expect when they say that they are closing without any communication with the towns people and the Sturbridge branch is the nearest branch". It is too bad that they are not keeping some type of presence in town. Maybe another bank could take their place was suggested by a resident. We will see what will happen probably this next couple of weeks. Mr. Eichacker said Thank you to all who wrote letters and called. We have kept the bank opened for 4 weeks longer than what they said.

### 12. Comments and Concerns:

a. Memorial Day was a great event. Thank you, Becky Acerra, and Rich Demetrius, for doing such a great job organizing it. We had a good turnout, with the Fire, Police and Travis from WCAT running around videotaping it. Great Event. Thank you all who

participated.

b. Had a resident email Mr. Dufresne about a piece of property on Pine St. that a house was taken down and the lot is all overgrown now. Mr. Dufresne checked with Dawn and the town doesn't own the lot yet. So, we cannot do anything with the property. Once we do own the property, we will have an auction to sell it. Until then it is the owner's responsibility to maintain the property. Chief Lavoie made the comment that there was a fire and the home had to be demolished due to a dangerous situation.
