Call Meeting to order 6:00PM Pledge of Allegiance

1. In accordance with MGL c 140, §157, the Board of Selectmen has scheduled a hearing in response to written and verbal complaints received by this office relative to incidents involving a dog residing at 250 Reed Street: Mr. Dufresne swore everyone in. After listening to the testimonies of everyone at the meeting Mr. Dufresne stated that no one at the meeting had seen the incident, that everything was 3rd hand and therefore there were no grounds for the dangerous dog hearing. Mr. Eichacker made a motion to close the dog hearing due to this charge was unfounded 2nd by Mr. Dufresne AIF passed.

- School Budget meeting: No one from the School Committee showed up. Mr. Dufresne stated that we are trying to work out a budget before July 1st so that the Regional School District does not need to lay off teachers. Mr. Eichacker said that we invited them to our meetings to accommodate getting enough meetings in before they must send out letters of layoffs. Mr. Kopacko stated if any other department in town would ask for this much money after they were to level fund, they would not get the money. They will also come to FinCom and the Board of Selectmen to talk about it. They may not like what the Select Board might say, but in the end, they would make the budget work. We have scheduled five meetings, but they have not come to any of them yet. We have even looked at a Special Town Meeting date to get this worked out before July 1st. We have reserved ½ of the time of our meeting for them to come and speak with us. Still nothing.
- Discussion with the Veterans Council about the Veteran memorabilia that is being stored at the West Brookfield American Legion. No one from the Veterans Council came to speak about the Veteran's memorabilia asking for them to return it to the Town. The Veteran's Council is looking to display the memorabilia in town. Since the Select Board gave it to West Brookfield, we need to ask for it back.
