- 2. As a company, how do you decide whether a site is appropriate for a solar field?

Do you do an environmental impact study first?

3. How familiar are you with the boundaries and landscape of abutting properties?

The drawing shows no retention pond on the west side. It is very steep. There is a pond, dam, and stream below.

4. Approximately how many trees are within the 51 acres proposed to be clear-cut for this solar field? are any trees in the wetlands to be out?

If each tree has the potential to store 100-300 gallons of water, how much pasture grass would be needed to equal the storage/absorption capacity of one tree? What is the ratio?

- ** How long would it take to clear 51 acres of trees?
- 5. What is the route the trunk line would follow to hook into the grid?
- What is the plan to gain access to the land proposed for the field? (Logging trucks, equipment trucks, worker vehicles, etc.

The existing access from Bragg is narrow and steep. On the west side there is a historic stone wall, mature shade trees, and a culvert. On the other side, there is a telephone pole near the proposed entryway.

- 7. Where would the staging area be? (Bragg is a narrow, fragile road. It could not accommodate large vehicles or a large number of worker vehicles and remain open for thru traffic)
