The Pledge of Allegiance

ANR-James Allard- 430 Cutler Road Ext.

Plan depicts three (3) lots (Map 2 Lots 6 & 6.2 & 6.3) Create lot 6.3 to convey to Mr. Allard form Mrs. Lavine to make an access strip of land (591sq. ft.) to join with lot 6.2 to create a Rear Lot. Upon conveyance Lavine to Allard of 6.3 lot 6.2 will be subdivided to create a Rear Lot.
